

EAMHID 2021 welcomes submissions from research and practice related to intellectual disability and mental health, both from academic researchers, the professional community and participatory projects from people with intellectual disabilities either alone or co-produced. The abstracts will be published in a special issue of the Journal of Intellectual Disability Research (JIDR).

## **PROPOSAL FORMATS**

The conference welcomes proposals in the following formats:

#### **Oral Presentations**

- Presenters should highlight the impact of their research in the everyday lives of persons with ID.
- Individual papers will be thematically clustered into symposia.
- Please add up to five keywords from the list on the right
- Duration of each presentation: 15-20 minutes plus 5 minutes discussion

#### Solicited Symposia

- Developed by a group of 3–4 colleagues who present and debate their research related to an overall topic.
- The symposia should consist of one abstract for the overall symposium plus 3–4 abstracts for the individual presentations within it.
- The submitting author will co-chair and moderate the symposium.
- Duration of each presentation: 15–20 minutes plus 5 minutes discussion
- Overall duration: 90 minutes (max. 4 presentations)

#### **Co-Productive Symposia**

- Typically generated by a group of up to 5 stakeholders. This will include: An emphasis on the principles of co-production, i.e. recognition of service users and other stakeholders as being assets in developing and delivering approaches based on people's capacities rather than deficiencies.
- Working in mutual partnerships and networks in which there is a sharing of roles and in which professionals act as catalysts for change.

- Overall duration: 90 minutes

#### **Roundtable Discussions**

- A range of topics will be considered covering varied and uncertain opinions often based on missing and/or inconsistent evidence.
- The submitting author puts forward an abstract on their selected theme (e.g. »Ageing with ID – A privilege or a burden?«) and a number of debating experts.
- In the abstract, the main positions and arguments should be summarized in the background section, the aims within the results/aims section as well as the names of the debaters in the author section.
- The submitting author will co-chair and moderate the roundtable by opening the floor and include the audience.
- Duration: 45 minutes

#### **Posters**

- Ongoing and recent work can be presented with posters as printouts (A1 Format).
- Sessions will be organized thematically by the scientific committee. Authors should be available during the poster sessions for individual debates.
- Please upload your poster as a PDF (max. 10 MB).
- There will be an award for the best poster presentation.
